New Brazilian Law Recognizes Emotional Abandonment: What Parents and Advocates Should Know

Brazil has recently passed Lei 15.240/2025, a groundbreaking law that formally recognizes [emotional abandonment of children and adolescents](#) as a civil wrong, making it possible to seek compensation for moral damages.

While this is a Brazilian law, it signals a global shift toward recognizing children's emotional well-being as a key component of parental responsibility: a principle that has direct relevance for families affected by parental child abduction (PCA).

What the Law Does

The new legislation expands parental obligations beyond financial support to include emotional care, presence, and guidance. Emotional abandonment is now recognized as a violation of fundamental rights, and courts in Brazil can award civil damages for failures to meet these responsibilities.

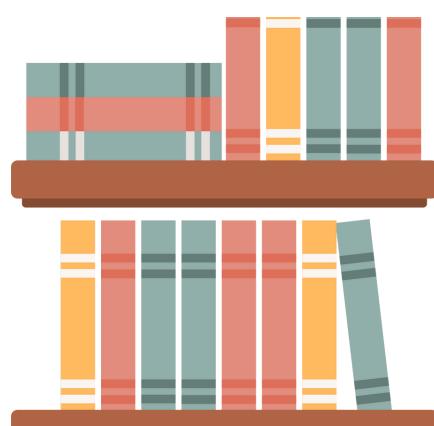
While the law does not solve all challenges faced by left-behind parents, it underscores a growing recognition of the real emotional

harms caused by parental absence: a step toward justice and accountability that families and advocates can embrace as part of their ongoing efforts.
